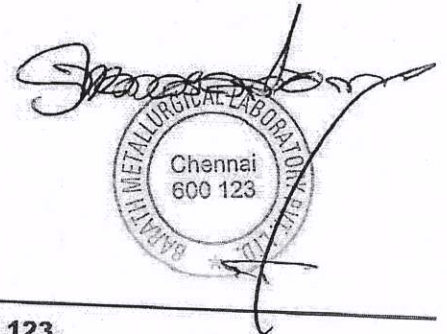

3. Scope of Testing Services

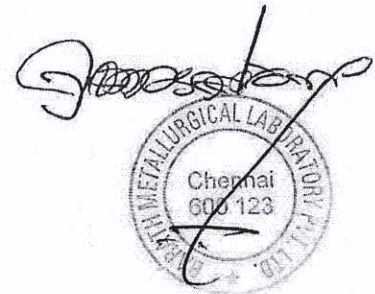
BML agrees to carry out the following testing services for Hevea:

Testing parameters include:

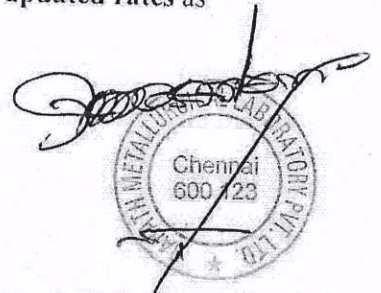

- Use reports strictly for approved technical and regulatory purposes, including RDSO submission.

7. Confidentiality

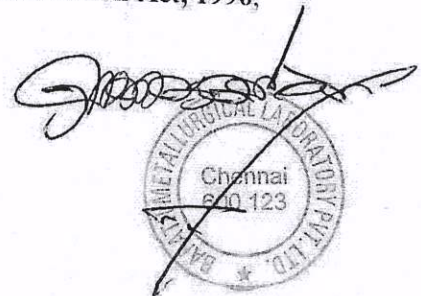
All technical information, test data, pricing, and communication exchanged under this MoU shall remain confidential unless required by statutory authorities such as RDSO.
